Editorial





German nuclear decision to phase out nuclear power completely by 2022 paves the way for more renewable energy. Combined with the Swiss decision to close the door to future nuclear power and the Italian referendum where the voters once again (like after Chernobyl) said no to nuclear reactors, the political fallout from Fukushima in Europe is rather significant.

The conclusion for investors can only be one: the political and economic risks associated with nuclear power are too high. Whenever a large nuclear accident occurs, wherever it happens in the world, there is a risk that democratically elected politicians will make the investments worthless.

Beside this political risk, the nuclear industry has to fight increasingly competitive renewable technologies. It can be clearly seen in the recent report from IPCC that the costs of RES per kWh are constantly falling: (access IPCC report). At the same time the costs for nuclear investments rise.

On a global scale the renewables show a great growth. Nevertheless, the contribution from renewable energy is often underestimated and misleading. For example, BP in its Statistical Review of World Energy writes that renewable energy's share of global energy consumption is only $1.8\,\%$ whilst the correct number is $12.9\,\%$ – BP has excluded all bioenergy use in industry and households.

On this note, I am looking forward to meet you all at our AEBIOM conference in Brussels on 29-30 June and I wish you a restful summer.

▶ ENplus training for auditors on 10-11 October in Vienna

EPC is organizing training for the auditors from inspection bodies (listed by EPC) that wish to perform ENplus related audits of pellet production plants and pellet traders' facilities. The participation in this training is considered as an adequate proof of qualification for those who intend to audit pellet plants

(see the requirements stated in the ENplus handbook). The training will include an introduction to the relevant EN standards, the requirements of ENplus, practical training in defining physical parameters of pellets and audits of two modern pellet production plants. The training will take place on 10-11 October in Vienna, Austria. A detailed description of the training can be found via the link below.

▶ EIBI: the EC publishes a call for expression of interest

The European Industrial Bioenergy Initiative (EIBI) is one of the six priority industrial initiatives of the Strategic Energy Technology (SET) Plan that aims to provide funding opportunities to large scale bioenergy projects (seven innovative bioenergy value chains).

The EC has just published Call for Expression of Interest (EoI). EoI aims at gathering information regarding demonstration and flagship projects that would be ready to be launched and fulfil the basic EIBI eligibility criteria. By participating in the Call for EoI, industry will not only help to unlock additional support but also help to shape the future prioritization of value-chains and the design of selection procedures of projects. ▶ Energy Council discusses sustainability issues brought up by Nordic EU countries

The Council that took place on 10 June briefly discussed the sustainability issues that were brought up by the Swedish delegation with support of Austria, Finland, Slovenia, Latvia, Lithuania and Estonia. The Swedish delegation prepared an information note presenting common points and concerns about the detailed and harmonized sustainability criteria for biomass. These delegations believe that any Commission's proposal on this topic must take into account the diversity in forestry and that detailed criteria could be defined at national level.

▶ European forests are increasing and offset 10% of EU GHG emissions

The ministers responsible for forests, high-level representatives of 43 European countries, the European Community and observer countries and organizations have gathered together during the FOREST EUROPE Ministerial Conference that was held on 14-16 June 2011 in Oslo, Norway. The conference provided an opportunity to discuss and take decisions on the future of the protection and sustainable management of forests in Europe.

During this conference, an international forest expert Christopher Prins presented a comprehensive and fact based report. The report shows that European forests are expanding whilst removing the equivalent of about 10% of European greenhouse gas emissions; the sector provides four million jobs and accounts for one percent of the region's gross domestic product; and the low carbon-nitrogen ratio in forest soils will be problematic in several locations.

The conference was an important event for the forestry sector as the conference participants adopted the Oslo Ministerial Mandate for Negotiating a Legally Binding Agreement (LBA) on Forests in Europe, as well as the Oslo Ministerial Decision: European Forests 2020, which outlines a vision, goals, targets and actions for Europe's forests. The negotiations on the LBA will most probably start later in 2011, and will conclude by mid-2013.

▶ EU budget for the years beyond 2013 aims to be greener than ever

The EU is deciding on budgetary priorities for the years beyond 2013. The multiannual financial framework lays down maximum amounts (ceilings) for each broad category of expenditure (headings) for a clearly determined period of time (several years). The European Parliament, in its vote on June 8, 2011, made proposals for the new multiannual Financial Framework for the European Union. Amongst many other points, the EP is convinced that the energy's share in the next MFF should increase. EP believes that renewable energy technologies, energy efficiency and energy saving should be key priorities and calls for a corresponding increase of EU funding in these areas and calls for an appropriate action in this area. The next MFF will be more important for the environment and the sustainability of the European economy.

▶ EP report on energy infrastructure priorities

The European Parliament has published a report on 14 June on energy infrastructure priorities for 2020 and beyond. Amongst many notes, the report stresses the importance of decentralized energy production and priority access to the grid for renewables. The report also stresses the need to prepare and adapt grids for the production of forms of energy such as electricity and biogas from agriculture and forestry sources, as a result of a reformed common agricultural policy.

▶ EC proposes a directive on energy efficiency

The European Commission on 22 June has published a proposal for a directive on energy efficiency. The energy efficiency directive outlines ways in which member states can reduce wasted energy. The EC notes that a mandatory CHP and district heating and cooling requirements for new electricity generation installations would significantly improve energy efficiency in generation. The proposal, however, suggests granting a priority access of high efficiency cogeneration to the electricity grid, meaning that fossil fuels will have a priority access to the grid as well. The paper counts a number of proposals on how to ensure a CHP and district heating development at all levels and thus save energy. The proposal indicates that member states should take necessary measures to develop these sectors and ensure energy efficiency by using renewable energy sources and waste heat.

AEBIOM POSITION ON EU ENERGY POLICY

▶ AEBIOM and EBA pushes for sustainability criteria of solid and gaseous biomass

AEBIOM together with EBA (European Biogas Association), on 30 May, published a position paper supporting the introduction of a harmonized European sustainability framework if such a scheme takes into account the particularities of biomass sector.

The paper highlights that a significant increase in imports by 2020 represent a higher risk of unsustainable biomass production which can be minimised by implementing a harmonized sustainability criteria. Nevertheless, a sustainability scheme should be flexible and take into account/include the existing national and regional legislation. Furthermore, the costs of such sustainability criteria should not become a burden for small bioenergy producers, thus, lighter administrative procedures should be applicable for small bioenergy players.

▶ IPCC publishes a report on renewable energy

The IPCC has recently published a report on Renewable Energy Sources and Climate Change Mitigation (SRREN). The publication presents an assessment of the literature on the scientific, technological, environmental, economic and social aspects of the contribution of six renewable energy (RE) sources to the mitigation of climate change. It is intended to provide policy relevant information to governments, intergovernmental processes and other interested parties. The chapter 2 is focused on bioenergy.

EU PROJECTS

▶ EUBIONET III workshop on sustainability of solid and gaseous biomass and a publication on new and unexploited biomass resources

The workshop "Sustainability of solid and gaseous biomass" organised within the EUBIONET III project (supported by the IEE) in cooperation with University of Utrecht and IEA Task 40 will focus on analysis of the existing sustainability schemes, positive and negative impacts of sustainability criteria for market players and the implementation particularities. The event will be chaired by Silvia Vivarelli from EACI and Giulio Volpi from the European Commission. The sustainability criteria will also be analysed from a perspective of the European Investment Bank. This, free of charge workshop, will be held within the European Bioenergy Conference on 29 June in Brussels.

The project partners have also issued a publication in May on new and unexploited biomass resources in Europe. The publication indicates that there are 54 new and unexploited biomass resources in Europe. The report shows that around 5.9 million tons dry matter of these new materials are used annually (1.9 - 2.4 Mtoe) whilst estimated potential reaches 18-22 million tons dry matter annually (6.5 - 7.9 Mtoe).
